Query	Answer
Administrative Fee	Pursuant to Sec. 31 of RA 9184 and its Revised IRR:
	"The ABC shall be the upper limit or ceiling for acceptable bid prices. If a bid price, as evaluated and calculated in accordance with this IRR, is higher than the ABC, the bidder submitting the same shall be automatically disqualified. There shall be no lower limit or floor on the amount of the award".
	It is further emphasized that the proposed bid price should not exceed the ABC; the bidder should also ensure that the prescribed statutory rates on salaries and benefits due to its security personnel are complied with.
	Please be aware also of the Statement in Number 7 and 8 on Omnibus Sworn Statement (Revised) of the Philippine Bidding Documents.

This Supplemental Bid Bulletin No. 3 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
