
Query	Answer
1. Administrative Fee	<p>Pursuant to Sec. 31 of RA 9184 and its Revised IRR:</p> <p>"The ABC shall be the upper limit or ceiling for acceptable bid prices. If a bid price, as evaluated and calculated in accordance with this IRR, is higher than the ABC, the bidder submitting the same shall be automatically disqualified. <u>There shall be no lower limit or floor on the amount of the award</u>".</p> <p>It is further emphasized that the proposed bid price should not exceed the ABC; the bidder should also ensure that the prescribed statutory rates on salaries and benefits due to its security personnel are complied with.</p> <p>Please be aware also of the Statement in Number 7 and 8 on Omnibus Sworn Statement (Revised) of the Philippine Bidding Documents.</p>

This Supplemental Bid Bulletin No. 3 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
